

Supplemental Provision - Bahrain

This Bahrain Supplemental Provision (the “**Supplement**”) supplements the information contained in the Citi ICG Global Privacy Notice (the “**Privacy Notice**”) and applies solely to individuals who have rights under Bahrain Law No. (30) of 2018 with respect to Personal Data Protection Law (the “PDPL”) (“consumers” or “you”). Unless otherwise defined in the Privacy Notice, any terms defined in this Supplement have the meaning used in the PDPL. Where there is a conflict between the Supplement and the Privacy Notice, the terms of this Supplement will prevail to the extent of any inconsistency.

Purpose and Use

We will only use your personal information for the purposes set out in the section of the Privacy Notice titled Purposes and Uses of Personal Information. Where we require to use your personal information for any new purposes which are unrelated to the original purposes for collecting such personal information, we will seek your written, explicit, clear, specific and voluntary consent.

Cookies

Most web browsers are set to accept cookies by default. You may choose to remove or reject cookies through your browser settings if you prefer. Please note, however, that doing so may affect the availability and functionality of certain features of our Services.

Yours Rights

In addition to the rights stipulated under Your Privacy or Data Protection Rights of the Privacy Notice, you have the following rights as well, as stipulated by PDPL:

- (a) Right to object to processing for direct marketing purposes

We will inform you of your right to object, free of charge, to the processing of personal data for direct marketing purposes.

- (b) Right to object to processing causing material or moral damage

You have the right to request that we stop processing your personal data if the processing is causing, or is likely to cause, unwarranted substantial material or moral damage to yourselves or others. Upon receiving a request with reasons, evidence, and proof of identity, we will cease processing wholly, or for a specific purpose or in a specific manner, within ten (10) working days. This right does not apply if the you have provided consent, or if the processing is necessary to perform a contract with you, to take steps at your request to enter into a contract, to comply with legal or court obligations, to protect your vital interests, or to pursue the legitimate interests of ourselves or a third party, provided these do not override the your fundamental rights and freedoms.

- (c) Right to object to decisions based on automated processing

Where the processing is intended to assess your performance at work, financial position, level of efficiency for borrowing, reliability, or behaviour, you have the right to object to such decisions and request that the decision be reconsidered through a non-automated review.
