



Introduction

Being a responsible corporate citizen includes engagement in the political process as a part of a strong Environmental, Social and Governance (ESG) practice. The potential impact of public policy on our business, employees, communities, and customers, is an important reason why Citi works to advance and protect the global business interests of the company. Citi's Global Government Affairs team works closely with business to advocate the company's interests through direct contact with government officials or in-directly through trade and business associations. Citi's Political Action Committees also support candidates that understand the important issues affecting the company's businesses.

This Report contains information regarding Citi's political contributions, lobbying activities and principal trade and business association memberships for the calendar year 2022.



Advocacy/Lobbying

United States Lobbying

In 2022, Citi reported federal lobbying expenditures of \$5.1 million. The company lobbied on matters including financial services and banking, housing reform, cyber security, tax policy, trade policy, municipal finance, and cross-border data issues.

In the states, Citi lobbied on matters regarding financial services and banking, privacy proposals, tax policy, ESG related issues, and HR/employment issues, while also raising awareness of Citi's commitment to closing the racial wealth gap, diversity and inclusion in the workplace, and broadening fair and equitable financial access.

International Lobbying

Outside the U.S., Citi's lobbying activities vary by country and span across multiple financial services industry matters, including, but not limited to legislative and regulatory reform initiatives in banking, capital markets and derivatives clearing, cross-border data issues, digitization, digital currency, e.g., CBDC, crypto, etc., bank taxes and international tax reform, ESG reforms and the creation of green bonds and more efficient secondary markets, sanctions policy, trade policy, market access, and diversity and inclusion reforms.



Compliance

Citi complies with all international, national, state, and local laws concerning lobbying registration and reporting. At the U.S. federal level, quarterly lobbying disclosures are filed with the U.S. Congress disclosing Citi's federal lobbying expenditures and the issues lobbied. 2022 U.S. Political Contributions

One of the most important political engagement tools we have continues to be Citi's employee-funded political action committee – Citi PAC. Through Citi PAC, we are better positioned to advocate on issues that impact our business, our colleagues, and the communities we serve across the country.

Financial support for Citi PAC comes solely through voluntary contributions from eligible employees who share the common interest of supporting Citi's efforts in the political process.

We evaluate Citi PAC support to candidates based on the following criteria:

- · Support of business issues important to Citi;
- Position on a committee with jurisdiction over policy issues important to Citi, or elected leadership position;
- Representation of a state or district where Citi has a significant employee presence;
- · Character and integrity; and
- Demonstrated commitment to bipartisanship, governing and protecting democratic institutions.

Description of Contribution Limits

Citi PAC-Federal Contribution Limits

Citi PAC-Federal makes contributions to federal incumbents, national party committees and Federal Leadership PACs.
Federal Leadership PACs are permitted to accept donations from individuals and other PACs up to \$5,000 per calendar year. Leadership PACs are established by a federal officeholder but are used to support other candidates for federal office. Citi PAC-Federal does not make contributions to state or local candidates, state or local committees, or state or local incumbents running for federal office.

The limits for the Federal PAC are listed below:

 \$5,000 per election to a federal candidate's campaign committee. That means \$5,000 may be given for the candidate's primary and \$5,000 for the general election, for a total of \$10,000 per election cycle.

- \$15,000 per calendar year to a national party committee:
 Democratic Congressional Campaign Committee (DCCC),
 Democratic National Committee (DNC), Democratic
 Senatorial Campaign Committee (DSCC), National Republican
 Congressional Committee (NRCC), National Republican
 Senatorial Committee (NRSC), Republican National
 Committee (RNC).
- \$5,000 per year to an incumbent's leadership PAC.

Citi PAC-State Contribution Limits

Contribution limits within the states and municipalities can vary greatly, from \$100 per election to \$50,000 per election. Citi PAC-State makes contributions, where permitted by law, to state and local officials, state political party committees, state leadership PACs, and national state legislative organizations.
