

## EMIR (EU and UK) INTERAFFILIATE EXEMPTION DISCLOSURE

The applicable EMIR national competent authorities have authorized that non-cleared OTC derivative contracts entered into between the following Citi entities (all such entities being affiliates consolidated within the same group of companies) are fully exempt from the clearing and initial and variation margin exchange requirements set out under Regulation (EU) No. 648/2012 of the European Parliament and of the Council on 4 July 2012 on OTC derivatives, central counterparties and trade repositories and as it forms part of domestic law of the United Kingdom by virtue of the European Union (Withdrawal) Act 2018 (together “EMIR”).
