Citi® Virtual Card Accounts (VCA) can improve the overall ROI of your eProcurement investment by combining robust payment controls and enhanced spend data with the internal controls and approval workflows you've set up as part of your eProcurement solution.

eProcurement solutions can improve the compliance, efficiency and visibility of organizations' sourcing and purchasing processes. When combined with VCA, these benefits – as well as the opportunity for working capital improvements and increased commercial card rebates – are extended further downstream in your P2P process.

VCA enables organizations to reduce invoice processing and paper handling, and to streamline payment, reconciliation and allocation processes by automatically generating singleuse virtual card numbers from your eProcurement system for every payment at the time of order.

Citi's flexible VCA solution provides enhanced security and data visibility when transacting with your suppliers. Unique, plasticless virtual card numbers are generated for each order with client-specified controls and reference data. Choose to send card numbers automatically to suppliers through secure e-mail or to include them when your system sends Purchase Orders (POs) through an existing process.

# **Increased Control**

VCA lets you define controls that determine exactly how, where and when each virtual card can be used for payment, ideal for organizations seeking greater control than offered by a traditional "ghost card" process:

- Number of Transactions: Create single-use virtual cards or allow multiple transactions per card
- Transaction amount limit: Set exact amount, maximum amount or a range
- Validity period: Start and end times, from one minute to two years
- Suppliers: Lock down use to a specific supplier or merchant category code (MCC)

### **Enhanced Transaction Reporting**

In addition to standard commercial card transaction data, clients enjoy robust VCA transaction reporting that includes each unique virtual card number and client-specified data elements to help with reconciliation and allocation processes.

Track PO numbers or other details to help automate matching of orders to card transactions, and capture General Ledger codes or cost centers for post-transaction allocation. You can also benefit from improved tax reporting and value-added tax (VAT) reclaim based on your suppliers' Level 2/3 data capabilities.

processes. The API is flexible and robust, ready for integration into most eProcurement systems.


